

Participants Terms and Conditions
UVID Dronetech 2024 Conference – November 7th, 2024
(the “Event”)

General Terms:

- The registration to the Event organized by ArrowMedia Israel Ltd. (the “Company”) is subject to completing the registration process in the registration page.
- You are aware and agree that some of the Services might be subject to a payment of a registration fee, and in that case, receiving the Services is subject to a full payment of the registration fee as detailed on the registration page.
- The dates and times of the Services may be changed or updated after the registration. The Company undertakes to update about such changes.
- Due to the fact that the services related to the Event are provided in collaboration with various companies and individuals and by the platform, in the event that Company is unable to provide the services because of any reason beyond its control, it has the right to cancel or postpone the provision of the services upon its sole discretion.
- All the content from any kind which will be provided during the Event is the intellectual property of the Company and you agree that by participating to the Event, you do not have any right in such intellectual property. You will not use, copy, photo, record, distribute, create, sell or lease any part of the intellectual property in any means without obtaining the prior written consent of the Company.
- You are required to demonstrate good manners when using the Services, and you agree to comply with all regulations applicable to similar type of event, including the venue rules and any health measures.
- You shall comply with all health measures enacted by the Israel Ministry of Health, from time to time, if any, and it is your sole responsibility to keep yourself up-to-date and check the last changes made by the Israel Ministry of Health. You should also comply with the health regulations of the Venue. The Venue shall have the sole discretion to not allow you to access to the Event if you do not comply with its regulations, and you agree to waive any claim you may have against us with regards to such matter.
- In its sole discretion and without refund, Company reserves the right to refuse admittance to or expel from the Event any participant that it determines is behaving in a manner that could be disruptive to the Event or to any other participant, or in a manner that is not in compliance with the general health measures.
- The participant shall not adopt behavior which is prohibited. Prohibited behaviors include but are not limited to intimidating, abusive, discriminatory conduct; offensive verbal comments; inappropriate use of nudity; harassing photography or recording; intentional disruption to other persons.
- By participating in the Event, you hereby acknowledge that we may take pictures and videos of you at the Event, and you provide us with a license to use any of these pictures and videos for the purposes of the Event and the promotion of future events.

Cancellation/Postponement Terms:

- **Cancellation by you:** You are entitled to cancel your registration the Event and receive a full refund of the fees originally paid to Company excluding if you notify Company prior to October 8th, 2024. If you notify the Company between October 9th, 2024, and October 20th, 2024, you shall receive a refund equal to 50% of the fees originally paid to Company. Following October 21st, 2024, no refund shall be provided.

In order to cancel your registration, a request must be sent to contact@uvidtech.com specifying the Registration date, Full Name, and Contact details of the Participant.

- Cancellation/Postponement by the Company: Postponement or cancellation of an Event by Company and/or change of display areas/name of the Event (a “Change”) will be at Company’s sole discretion and for any reason. The Participant hereby waives any argument and/or claim and/or demand in this regard. If the Event is cancelled, Participant shall be fully reimbursed for any sums previously paid by Participant with regards to this Proposal. If the Event is postponed, the Participant has the right to send a notice to cancel its participation as set forth within ten (10) days following notice of postponement, and the Participant shall be able to receive full refund of the fees originally paid. Company agrees that the postponed event shall take place in the thirteen (13) months following the original date of the event, otherwise the Participant shall have the right to cancel its participation and to receive a refund of the price originally paid to Company.
- In case of cancellation of the Event, you will be refunded according to the terms above within 28 days from receive cancellation request. A refund will be done by the same payment method chosen when making the registration.
- Participation to the Event is subject solely to Israeli law. Unique jurisdiction over all disputes relating to the Services is exclusively awarded to the competent courts of Tel Aviv city.
